TERMS OF REFERENCE

Position: Technical Expert (International) to support Fairtrade Certification and

Capacity Building of the Small Producers Organization (SPOs) and

SMEs in Bhutan linked to the project.

1. Background

The Bhutan Chamber of Commerce & Industry (BCCI) is one of the partners for **SWITChing India's Consumption to Fair and Sustainable Goods** project. The consortium project is led by Fairtrade International, Germany, as the lead applicant and contract holder of European Commission grant. The project activities are being implemented in three core countries (Bhutan, India and Indonesia) by the partner organizations of the project, namely Bhutan Chamber of Commerce & Industry, Centre for Social Markets, India, Fairtrade Foundation India, Transfair EV Germany and Max Havelaar France Association.

The BCCI is involved in project actions for two broad project outputs, namely, increased access to sustainably produced products in the Indian market and greater sustainability-led market linkages in Asian countries catering to Indian consumers. Against these broad project outputs, the BCCI collaborates with the Centre for Social Markets, India and Fairtrade Foundation India, the direct project counterparts of BCCI.

Some of the specific actions are:

- Developing market linkages in the Indian market for fast-moving consumer goods (FMCG) from Bhutan, with focus on fruits, vegetables and spices (fresh and processed).
- With the support of project partners in India, identify potential brands, retailers, processors in India who are interested to source agri-commodities from Bhutan.
- Facilitate certification (Fairtrade Certification) of agri-commodities supply chain actors in Bhutan develop market linkages with processors and buyers of certified products and raw materials in India.
- Collaborate with project partners and Fairtrade country network in India to support SMEs in Bhutan in terms of gap assessment to understand current operation and challenges, capacity building, certification advisory services, social

compliance support, training on Fairtrade standards, and conducting audit preparation for FLOCERT audits.

As the project embarks on applying for Fairtrade certification of the producers group and other SMEs linked to the project, there will be certain capacity building on Fairtrade standards, post-harvest Package of Practices (PoP) and other compliance requirement under the Fairtrade system.

2. Key Duties and Responsibilities

The Technical Expert shall:

- Undertake gap assessment of the small producer organizations (SPOs) and SMEs linked to the project to prepare for Fairtrade certification and other capacity building programs.
- Indentify and develop tailor-made post-harvest Package of Practices (PoP) and provide technical support on PoP to the target SPOs and SMEs in Bhutan.
- Identify and recommend post-harvest technologies as per the findings of PoP gap assessment.
- Conduct a thorough orientation of the project beneficiaries on Fairtrade system and its benefits.
- Conduct trainings on key aspects that are mandatory for meeting the Fairtrade standards, such as Occupational Health Safety (OHS), sexual harassment, discrimination, sustainable production practices, sustainable environment management, etc.
- Liaise between project beneficiaries, project implementation partners and certifying body to coordinate Fairtrade audit.
- Develop Standard Operating Procedures (SoPs) and any other documents necessary for certification and compliance.
- Evaluate sustainability compliance of Fairtrade certification by the SPOs and SMEs (post-certification advisory services).
- Provide Training of Trainers (ToT) on Fairtrade standard to the relevant stakeholders working with SPOs and SMEs in Bhutan.
- Travel to the project sites in Bhutan for the monitoring the activities of the SPOs and SMEs.
- Carry out any other activities that may arise as necessary in the due course of time.
