

TERMS AND CONDITIONS

1. The floor price for the vehicle is fixed at **Nu. 6,000,000.00** (Ngultrum Six Million) exclusive of applicable fees & taxes.
2. Prospective buyers are encouraged to inspect the vehicle at BCCI, Head Office, Doebum Lam, Chubachu, Thimphu during office hour from 4-25 March 2025.
3. The successful bidder is required to pay 25% of the tendered amount at the time of acceptance of tender or the next working day and the balance amount within ten (10) working days from the date of acceptance, failing which the offer will be cancelled, and the 25% deposit shall be forfeited.
4. The successful bidder shall lift the vehicle on the last day of final payment.
5. The earnest money of the successful bidder will be adjusted against the offer and the earnest money of the unsuccessful bidders will be refunded immediately after finalizing the tender.
6. The earnest money of the successful bidder will be forfeited if he/she refuses to accept the tender.
7. It will be assumed that the bidder has inspected the vehicle and satisfied as per the condition mentioned in the table below that they are bidding for and complaints of any mismatch of the condition of the vehicle will not be entertained later.
8. Vehicle registration shall be initiated only to the bidder who has submitted the bid, and the buyer will be responsible for all costs and formalities associated with registration and insurance.
